# SPECIAL INSTRUCTIONS

## OPENING TIMES and ORGANISATION

The Club is open every day including the weekend from 9.30 am to 5.00 pm.

### **The reception is closed from 12.30 to 2.00 pm (lunchtime)**

#### **Children must arrive:**

- Between 9.30 to 10.00 am for with/without lunch or full day sessions.
- Between 2.00 to 2.30 pm for afternoon sessions.

The manager may refuse entry to the Club to any child consistently arriving outside official arrival time for obvious reasons including: organisation, activities and safety.

## CONDITIONS OF ADMISSION

Children must be between 3 and 6 years old and must not have any contagious illness also must be **potty trained**.

In some cases a medical certificate of good recovery or of no contagion may be required for entering to the Club.

The booking form must be signed by the child legal guardian and should contain:

1. the health form (or immunization History) duly filled
2. A birth certificate.
3. The full payment

## SECURITY and RESPONSIBILITY

**The children's name must be marked on all their personnel belongings (gloves, hat, sun glasses or goggles...).**

The Club staff is not responsible for loss or theft of unmarked clothes or objects.

If a child must take medication, the Manager must be in possession of the prescription and medication.

No medicine can be given to the child without prescription.

If a child gets sick or has an accident during the day, the Manager will take the necessary measures (doctor or emergency services) and call the parents as soon as possible.

**However, your child is not insured by the Club. We strongly advise that you take out "the E-gloo Protect" ski insurance which covers the risk of accident and there are no refund or replacement lessons if your child misses the class.**

## ACTIVITIES AT THE CLUB

Everything is done to make parents' holidays as good as children's holidays...!!!

**The supervising staff reserves the right to judge the correct adaptation of your child in the Club, thus deciding whether or not to continue in his or her stay in order to preserve his or her well-being.**

The progress rhythm is adapted to the age of children.

Indoor, outdoor activities and skiing initiation are alternated under the supervision of qualified activity leader.

Meals and afternoon or morning snacks are included in the price. Meals served to the children are varied, balanced and of sufficient quality and quantity. Meals are identical for all children, except those subject to specific dietary: allergy, specific diets or religions... It's essential that you notified on the health form.

## EQUIPMENT

**The Club doesn't supply ski, ski boots and helmet. The helmet is compulsory.**

**The lockers are reserved only for children registered in Formula with lunch**

**Parents must supply the following items:**

- The first, please make sure children are equipped with ski, ski boots and helmet.
- A complete change (socks or tights and pairs of underpants) only for those with lunch cause of weather (snow or rain).
- For the comfort of your child, we advise you to bring any comforter or other object that may contribute to their well-being.
