You will benefit from the right to withdraw from this policy for a period of fourteen (calendar) days as from signing it, free of any charges or penalties, under the conditions of Article L. 112-10 of the French Insurance Code :

PROTECTION OF PERSONAL DATA

To benefit from the CARRE NEIGE service, your data and those concerning the beneficiaries will be processed by ALBINGIA, acting as Data Controller, in accordance with the provisions of Regulation (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data.

The Personal Data collected is intended for ALBINGIA, the Data Controller, as well as for entities that interact with ALBINGIA for the purposes of managing and following up on requests. Persons involved in the processing of requests may, without the Insured Party's knowledge, disclose the data to entities that interact with ALBINGIA and to third parties linked to ALBINGIA by contract for the performance of subcontracted tasks necessary for the management of requests, such as intermediaries and reinsurers, subcontractors and service providers, in compliance with the legislation on the protection of personal data and within the limits necessary for the performance of the tasks entrusted to them.

Within these limits, all information collected in connection with a request is kept confidential and as anonymous as necessary, with only the information that is strictly necessary being transmitted to the relevant recipients.

Personal Data is collected on the basis of legal and regulatory provisions, the performance of the contract, where applicable, and legitimate use, for the purposes of processing general requests, concluding or managing contracts and compensation, or managing commercial relations or combating fraud. The Personal Data collected will be kept for the duration of the contract, where applicable, plus the applicable limitation periods, particularly with regard to contract management and compensation, or for a period of 3 (THREE) years following the year in which a request was made if this is not followed by a commitment. At the end of the specified retention period, Personal Data will be deleted or anonymised.

In the event of a dispute, the Insured has the right to refer the matter to the National Commission for Information Technology and Civil Liberties. In the event of death, and in the absence of instructions from the Insured, the heirs have the right to object to the continued processing of the data or to have it updated.
